


#### Raphael Semmes on the cause of the War

The following conversation between English ship Captain Hillyar and Capt. Raphael Semmes-Confederate Ship CSS Alabama occurred during the war on August 5th, 1861. It is a summary from a well-educated Southerner who is stating his reasons for fighting.

Captain Hillyar expressed surprised at Captain Semme's contention that the people of the South were "defending ourselves against robbers with knives at our throats", and asked for further clarification as to how this was so, the exchange below occurred. I especially was impressed with Semmes' assessment of Yankee motives – the creation of "Empire"!

Semmes: "Simply that the machinery of the Federal Government, under which we have lived, and which was designed for the common benefit, has been made the means of despoiling the South, to enrich the North", and I explained to him the workings of the iniquitous tariffs, under the operation of which the South had, in effect, been reduced to a dependent colonial condition, almost as abject as that of the Roman provinces, under their proconsuls; the only difference being, that smooth-faced hypocrisy had been added to robbery, inasmuch as we had been plundered under the forms of law"

Captain Hillyar: "All this is new to me", replied the captain. "I thought that your war had arisen out of the slavery question".

Semmes: "That is the common mistake of foreigners. The enemy has taken pains to impress foreign nations with this false view of the case. With the exception of a few honest zealots, the canting hypocritical Yankee cares as little for our slaves as he does for our draught animals. The war which he has been making upon slavery for the last 40 years is only an interlude, or by-play, to help on the main action of the drama, which is Empire; and it is a curious coincidence that it was commenced about the time the North began to rob the South by means of its tariffs. When a burglar designs to enter a dwelling for the purpose of robbery, he provides himself with the necessary implements. The slavery question was one of the implements employed to help on the robbery of the South. It strengthened the Northern party, and enabled them to get their tariffs through Congress; and when at length, the South, driven to the wall, turned, as even the crushed worm will turn, it was cunningly perceived by the Northern men that 'No slavery' would be a popular war-cry, and hence, they used it.

It is true that we are defending our slave property, but we are defending it no more than any other species of our property - it is all endangered, under a general system of robbery. We are in fact, fighting for independence.

#### **MINUTES**

Quarterly meeting held December 3<sup>rd</sup> at the Hiram Parks Bell Camp meeting hall in Cumming, Georgia.

- 1. The meeting was called to order by Captain Johnny Sparks.
- 2. Captain Sparks announced that the membership in the state of Georgia is now divided into three troops. Troop 1 is west of I-75 and north of I-20. It is commanded by Freddie Parris Jr. Troop 2 is east of I-75 and north of I-20. It is commanded by Wedge Morrison. Troop 3 is south of I-20. Taz Cook is commander.

#### **Some Thoughts on Lincoln**

Lincoln used war to destroy the U.S. Constitution in order to establish a powerful central government. Lincoln illegally suspended the writ of habeas corpus; launched a military invasion without consent of Congress; blockaded Southern ports without declaring war; imprisoned without warrant or trial some 38,000 Northern citizens who opposed his policies; arrested dozens of newspaper editors and owners and, in some cases, had federal soldiers destroy their printing presses; censored all telegraph communication; nationalized the railroads; created three new states (Kansas, Nevada, and West Virginia) without the formal consent of the citizens of those states, an act that Lincoln's own attorney general thought was unconstitutional; ordered Federal troops to interfere with Northern elections; deported a member of Congress from Ohio after he criticized Lincoln's unconstitutional behavior; confiscated private property; confiscated firearms in violation of the Second Amendment; and eviscerated the Ninth and Tenth Amendments.

A New Orleans man was executed for merely taking down a U.S. flag; ministers were imprisoned for failing to say a prayer for Abraham Lincoln, and Fort Lafayette in New York harbor became known as "The American Bastille" since it held so many thousands of Northern political prisoners.

When the New York City Journal of Commerce published a list of over 100 Northern newspapers that opposed the Lincoln administration, Lincoln ordered the Postmaster General to deny those papers mail delivery, which is how nearly all newspapers were delivered at the time. A few of the papers resumed publication only after promising not to criticize the Lincoln administration. However many northern newspapers were burned and their owners imprisoned.

Lincoln ignored rulings hand-delivered to him by U.S. Supreme Court Justice Roger Taney ordering Lincoln to respect and faithfully execute the laws of the United States. Taney – and virtually all legal scholars at the time – was of the opinion that only Congress could constitutionally suspend habeas corpus, and had his opinion hand delivered to Lincoln by courier. Lincoln ignored it and never even bothered to challenge it in court.

Lincoln urged his generals to conduct total war against the Southern civilian population. Again, this is not even controversial. As pro-Lincoln historian Steven Oates wrote in the December 1995 issue of Civil War Times, Lincoln fully endorsed Sheridan's burning of the Shenandoah Valley, Sherman's brutal March to the Sea through Georgia, and the destructive raid through Alabama. Lincoln's war strategy was called the "Anaconda Plan" because it sought to strangle the Southern economy by blockading the ports and controlling the inland waterways, such as the Mississippi River. It was, in other words, focused on destroying the civilian economy.
